Financial:

Treasurer's Report and Voucher Payments: See attachments. The General Fund account has not been reconciled. PERA SmartSave with VOYA Financial initiated an unauthorized ACH debit for \$700 on April 16 and it cleared the bank on April 19. Nyleen spoke to First State Bank who printed out the information including the tracer number on this transaction. This has been submitted to VOYA for correction by no response yet. This transaction was initiated one week from the payroll submission on April 9 and one week before the payroll submission initiated on April 23. There is no payroll submission report in VOYA that coordinates to this date and so far according to VOYA, they did not receive the money. If VOYA is not able to correct this, Nyleen will contact the State Police and make a report. She will also contact PERA and the Office of the State Auditor Fraud Division. Vouchers were paid on a motion by Chris Lopez and second by Vernon Leseberg.

FY 2022 Budget Resolution: Nyleen sent out the draft FY 2022 budget for the board to review. Two corrections were made to correct the amount in the NMFA loan principal and the NMFA loan interest line items. This budget resolution passed on a motion by Chris Lopez and second by Vernon Leseberg. Roll call vote followed with Chris, Vernon, Lencho and Eddy all voting yes. **3**rd **Ouarter Budget Report:** This budget report was approved by DFA.

There are three projects remaining to be completed—Jay Santilles land leveling; Chris Lopez MRGCD turnout upgrade and Robert Rincones drip irrigation **Dissolution of RR Tie Program:** We were notified by NRAO that we cannot charge an administration fee to manage this program. Will also began looking into regulations regarding the use of railroad ties. According to the EPA, railroad ties should not be exposed to water and therefore not used in erosion control projects due to the various noxious chemicals in creosote. On a motion by Chris Lopez and second by Vernon Leseberg, the Socorro SWCD will no longer offer the railroad tie program. Staff will draft specifications to make erosion control a cost share eligible practice.
